Competitors in all events must be members of the EUSPBA or organizations with reciprocal membership agreements. Please have proof of membership with you. All competitors, except solo Grade 5 pipers and drummers must wear highland dress.

Complete entries, with fees must be submitted BY AUGUST 17, 2011. NO FIELD ENTRIES

- Competition begins promptly at 9:00 a.m.
- Any competitor not ready to perform when called will be disqualified.
- Gates open at 8:00 a.m. for competitors only. Gates open at 9:00 a.m. for all others. As a solo competitor you will be added to a roster for early gate entry. If you are not on the roster, you will not be permitted to enter until 9:00 a.m. Please check in at the Pipe and Drum H.Q.
- Judges' critique sheets, rankings and awards will be available at the Pipe & Drum H.Q. approximately 30 minutes after the completion of each Grade Event.
- Entries without signed Waivers will not be accepted.
- Registration confirmations will be sent via email where included.

The "Ian McPherson Award" will be awarded to the "Piper Of The Day".
